The forum will also be interesting for representatives of mutual funds, banks and participants of stock markets, investment, real-estate, development, construction and asset management companies.

The one-day program of the forum will provide participants with the opportunity to listen to the speakers at plenary sessions and discuss the questions of current importance in the following formats:

Plenary sessions

- Opportunities for institutional investors at securities market of Uzbekistan – presentations of local participants of stock exchange, the experience of international investment banks and funds in CIS markets 1

Theme sessions

- Financial and banking sector – perspectives of development of banking, insurance, leasing business in Uzbekistan, world experience, opportunities for strategic and financial investors, presentations of the banks

- Basic sectors, “blue chips” – presentations of companies operating in telecommunication, oil and gas, energy, mining, chemical and agricultural sectors
- Real Estate Market of Uzbekistan: management, investments, development – investment opportunities, risks, profitability, structure of supply, latest dynamics and prospects of market development. Insurance of construction risks as a factor of increasing the quality of projects

In the framework of the forum, there will be organized the “road-show” along successful companies and prospective real estate in Tashkent in May 30, 2007. The final event will be a sightseeing tour to historical cities Samarkand and Bukhara in May 30 – June 2, 2007.
