Only attorneys with a minimum of 90 points or higher are eligible to be included in the rankings.

The questionnaire includes general inquiries on the attorney's legal ability; negotiating, drafting, and oral advocacy skills; and ability to develop creative solutions when faced with new issues. Other questions include: does the attorney get personally involved to the appropriate level in his/her cases; how well does the attorney staff a case or matter; how much does the attorney add to the body of knowledge in his/her practice area; and would you retain this attorney to handle a matter for yourself or a close family member?
