East Moline, IL and Indore, India (September 30, 2008) – With the pre-registration deadline of December 1, 2008 quickly approaching for the European Union’s new regulation for Registration, Evaluation, Authorization, and Restriction of Chemicals (REACH), organizations are seeking solutions and assistance from partners to handle the complexity of adhering to this new regulation. SAP released a comprehensive REACH Compliance solution in August 2008 to tackle business disruptions associated with this regulation and alleviate substance usage, management, and logistical and legal processes.
